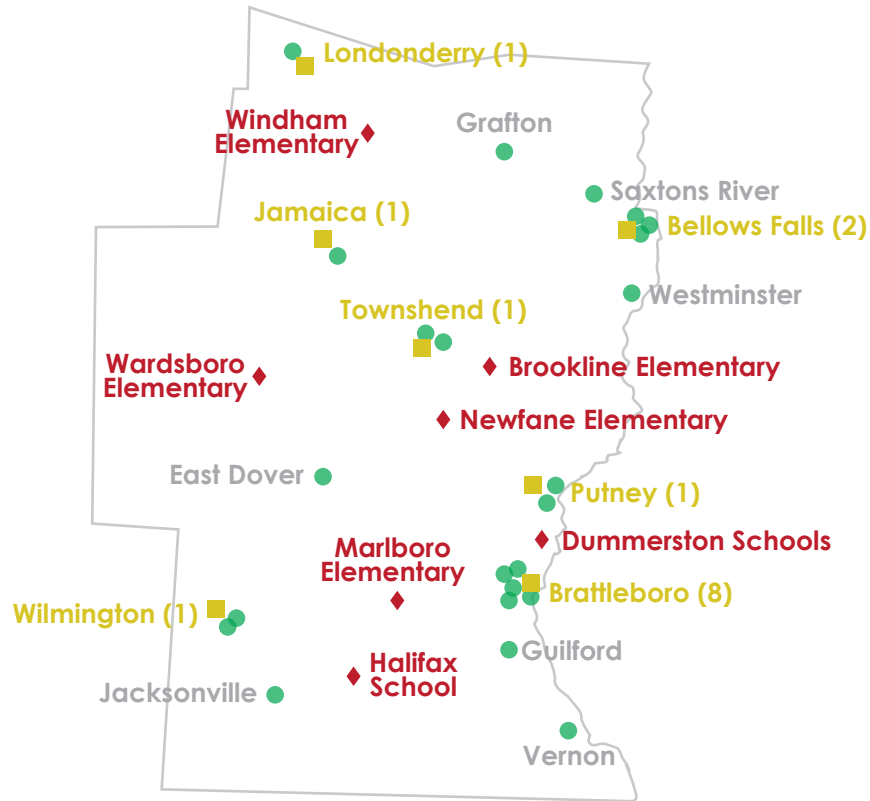


# Hunger is on the rise in our state. How strong is the safety net in Windham County?

**1 in 5** children in Windham County are food insecure.<sup>3</sup>

“ I buy in bulk and then we separate it so we can get more meals, and when my kids are not eating much a big package of hamburger will last us three meals. When we run low or we run out, I say to the kids, “let’s go down to grandma’s house” and they know when dinner is so they go, and when they come home, they’re not hungry.”

**6,905** number of county residents participating in 3SquaresVT, formerly known as Food Stamps.<sup>2</sup>

**43%** county-wide increase in 3SquaresVT participation over last year.<sup>1</sup>

**42%** of grade school and high school students eligible are for free or reduced-price meals.<sup>4</sup>

**57%** of those students are participating in school breakfast programs.<sup>5</sup>

**13%** of schools are offering afterschool snacks through the federal snack program.<sup>6</sup>

**31%** of child care centers participate in CACFP, the Child and Adult Care Food Program, which provides nutritious meals to preschool and afterschool programs.<sup>7</sup>

**228** county residents served each month through the Commodity Supplemental Food Program.<sup>8</sup>

**15** summer food sites.<sup>9</sup> \* Data sources on reverse

# What You Can Do to Combat Hunger

## PROVIDE FOOD RESOURCES TO YOUR CONSTITUENTS

### *3SquaresVT (formerly the Food Stamp Program)*

3SquaresVT stretches family food budgets by providing eligible Vermonters with additional money to spend on food. Currently, 84,300 Vermonters are enrolled bringing over \$10 million into the state each month to be spent locally.
